



## **POLICY & PRIVACY**

CEO Clubs Network protects the security and privacy of our members' data. The policy outlined below will help you to understand membership process including criteria, benefits, right, liability and others, and data privacy such as what type of data the Club may collect, and how it is used, safeguarded and with whom we may share it.

### **Personal data**

Through our Website, the CEO Clubs will not collect any personal data about you (e.g. your name, address, telephone number or e-mail address), unless you voluntarily choose to provide us with it (e.g. by registration or survey), provide your consent, or unless otherwise permitted by applicable laws and regulations for the protection of your personal data. As new Memberships are activated, the respective data is posted onto the member-only area of the CEO Clubs website or CEO Clubs Mobile App

### **Purpose of Use**

When personal data on membership application and in our member login system, it is used primarily to identify and recognize members to communicate with members, to respond to your inquiry, process your order or provide you with the access to specific information, B2B meeting, business match-making or any special offers, which is to bring the great experience to our valued members

Stored and processed Member data may be shared with our worldwide Chapters/affiliates to better understand your business needs and determine how we can improve our products and services

Personal data may be used to contact you about providing you supports in relating to your preference and your interest

Data may be shared with a third party in order to complete delivery of necessary CEO Clubs Network communications/documents to the CEO Clubs Membership process.

If you choose not to have your personal data used to support our CEO Clubs Network management and member relationship (especially direct marketing or market research), we will respect your choice. Your personal data will not be sold or transferred to a third party for any use other than listed above.

## **Purpose Limitation**

The CEO Clubs Network will collect, use or disclose personal data supplied by you online only for the purposes disclosed to you, unless the disclosure:

is a use of the personal data for any additional purpose that is directly related to the original purpose, for which the personal data was collected,

is necessary to prepare, negotiate and perform a contract with you,

is required by law or the competent governmental or judicial authorities,

is necessary to establish or preserve a legal claim or defense,

is necessary to prevent fraud or other illegal activities, such as willful attacks on the CEO Clubs information technology systems.

## **Communications or Utilization Data**

Through your use of telecommunications services to access our Website, your communications data (e.g. Internet protocol address) or utilization data (e.g. information on the beginning, end and extent of each access, and information on the telecommunications services you accessed) are technically generated and could conceivably relate to personal data. To the extent that there is a compelling necessity, the collection, processing and use of your communications or utilization data will occur and will be performed in accordance with the applicable data privacy protection legal framework.

## **Non-Personal Data Collected Automatically**

When you access our Website, we may automatically (i.e., not by registration) collect non-personal data (e.g. type of Internet browser and operating system used, domain name of the Web site from which you came, number of visits, average time spent on the site, pages viewed). We may use this data and share it with our business partners to monitor the attractiveness of our Website and improve its performance or content.

## **Security**

To protect your personal data against accidental or unlawful destruction, loss or alteration and against unauthorized disclosure or access, the CEO Clubs Network uses technical and organizational security measures.

## **Membership to Company**
